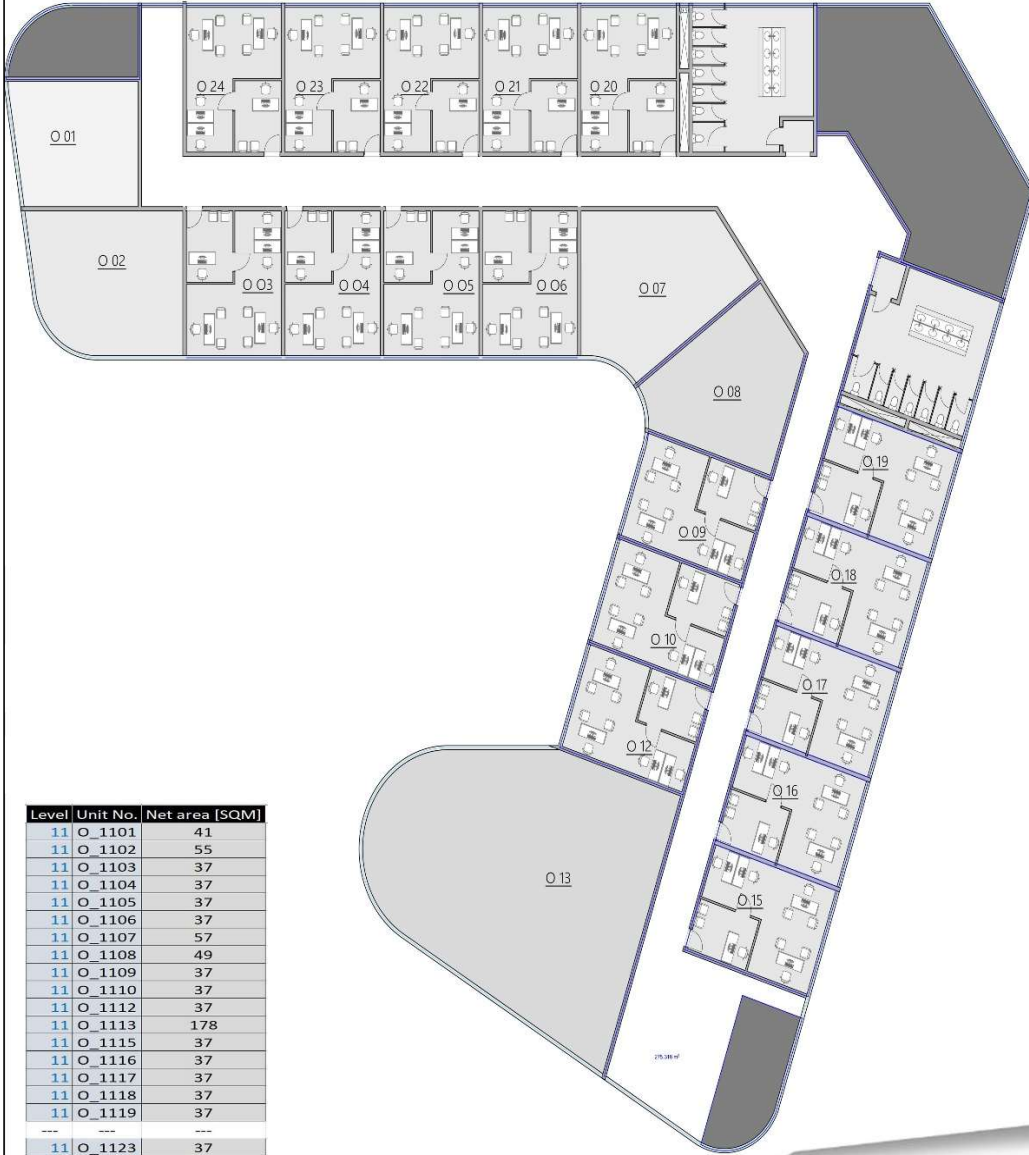
4. The Offices Start from 11th Floor to the 15th Floor
